### **Minutes for 7 April 2016**

The regular monthly meeting of the Gualala Municipal Advisory Council (GMAC) was held Thursday, 7 April 2016 at the Gualala Community Center, Gualala, CA. Council Members present were Barry Ducharme, Ron Eckert, Charles Ivor, Robert Juengling, Eric Mills, and Jeff Watts. Administrative Secretary Mary Mobert and three members from the public were also present (see sign-in sheet and speaker's cards). Chair Council convened the meeting at 18:35.

  i. Update on Status of the Gualala Refined Streetscape Design Plan (Phil Dow, Executive
  Director of Mendocino Council of Governments (MCOG))

Mr. Dow opened the discussion by stating that Transportation Funding has its Ups and Downs. Every other year MCOG submits its Regional Transportation Improvement Program (RTIP), which is the local input into the State Transportation Improvement Program (STIP). Capital projects, such as the Gualala Streetscape Project, are programmed through MCOG, from gasoline tax and truck weight fees

(Federal and State resources). After February's news that due to lack of revenue, over 3 million dollars of Mendocino County's projects would likely need to be de-programmed; the Gualala Streetscape project (Environmental Phase) appeared to be on hold. However, being that the Gualala project is due for its first allocation of \$340,000 for the Environmental Phase in this fiscal year ending June 30th, there is good news again, as Gualala is back on track to begin its Streetscape project this year. \*\*(Minutes 00:16:30 to Minutes 01:02:20) - \*\*Other MCOG items (Minutes 01:02:20 to 01:20:25)

Drought: State of Emergency & Status of the Gualala Water Moratorium (Council Members Ivor & Juengling) Per United States Geological Survey (USGS) North Fork Gualala River water flow is at 70 cubic feet/second.   - a. Review of Public Forum held at the Gualala Community Center 17 March 2016 re: THP #1-15-042 SON (Dogwood): The overwhelming feeling at the Forum, by the citizens of the greater Gualala area, was that the proposed Timber Harvest Plan (Dogwood), should not be allowed to move forward. There were over 70 audience members in attendance, and most everyone present was extremely upset about the proposed THP plan within the floodplain of the Gualala River. The overriding majority of attendees at the Forum would like to see the Floodplain become parkland, as was proposed by Sonoma County as far back as the 1960's, and like what has been done in other Mendocino County areas such as Big River. CalFire did not attend the Forum. Henry Alden, representative of Gualala Redwood Timber, gave an explanation of the proposed logging operation.
