Applicant Request: Standard Coastal Development Permit for a Capital Preventative Maintenance project to upgrade and replace highway asphalt, guardrails, traffic striping, delineation, roadside signs, driveway and side road conforms, bridge approach transitions, install shoulder backing, and the placement of concrete vegetation control under guardrails. Project Location: State Route 1 (SR1), located between Post Mile 14.1 in the City of Point Arena and the intersection of Philo Greenwood Road (CR132) and SR1.
