8. Public Agency Referrals - Discussion or Action

8.1. [CDP-2021-0052; Dunya Alwan](#) (Lewis, Juengling)

Applicant Request: Standard Coastal Development Permit to develop a newly restored bluff top parcel with: 1,220 sq. ft. footprint single-family residence including decks at grade with maximum height of 20 feet, 640 sq. ft. footprint accessory dwelling unit / workshop / garage, 1,200-gallon concrete septic tank and 934 sq. ft. leach field and 934 sq. ft. future replacement field, hot tub, hook-up to Gualala Water Company, PG&E electric drop, 200 linear feet gravel driveway extension, placement of two storage containers during construction, and 500-gallon propane tank on piers for backup power. Also proposed is use of a travel trailer during construction.

Site address: 34620 So. Highway 1, Gualala.

Additional information: GMAC considered this project on 9/5/24, with recommendations submitted to the county thereafter.

Recommended actions: discuss the proposal and determine comments/recommendations to Mendocino County Planning and Building Services.

8.2. [CDP-2022-0021; Hassan and Deborah Ghamlouch](#) (Juengling, Shpak)

Applicant Request: Standard Coastal Development Permit to construct a 1,458 square foot residence with 482 sq. ft. of decking. Additional development to include an 80 square foot pump house and 231 square foot concrete pad for water tanks at existing well, a foot bridge crossing at culvert, septic, necessary utility lines, driveway access to Highway 1, fence, pedestrian and car gates, gravel walkways with path lights, and removal of an existing shed.

Site address: 33300 So. Highway 1, Gualala.

Additional information: Caltrans has approved the proposed access from State Route 1. GMAC considered this project on 3/2/23, with recommendations submitted to the county on 3/9/23.

Recommended actions: discuss the proposal and determine comments/recommendations to Mendocino County Planning and Building Services.

8.3. [CDPM-2025-0008; Christina De Lopez](#)

Applicant Request: Coastal Development Permit for repairs and improvements to an existing single-family residence, including (1) a 112 square foot addition, (2) new roofing, (3) new siding, (4) a replacement deck, and (5) new exterior lighting.

Site address: 34400 So. Highway 1, Gualala.

Additional information: the proposed addition would replace an existing concrete slab adjacent to the residence. The applicant originally proposed a new 500 square foot detached garage northeast of the existing residence, but the structure would have been located within fifty (50) feet of nearby Environmentally Sensitive Habitat Areas (ESHA), inconsistent with County regulations. As such, the applicant has removed the garage from proposed plans. GMAC considered CDP-2022-0035 for this project on 2/2/23, which the county then approved on 6/8/23.

Recommended actions: discuss the proposal and determine comments/recommendations to Mendocino County Planning and Building Services.

8.4. [CDP-2025-0028; Tamara and Dean Weber](#) (Shpak)

Applicant Request: Administrative Coastal Development Permit to authorize the work completed under EM_2025-0005 to repair the septic system that serves Cabin #1 and replace the septic system that serves Cabin #2 and #3.

Site address: 36300 Fish Rock Road, Gualala.

Additional information: the three septic systems that serve Cabins #1, 2, and 3 were failing, resulting in improper wastewater disposal and the risk of environmental contamination to groundwater and ground surfaces. The emergency was the result of improper leach line and leach field installation (Cabins #2 and #3) and minor root intrusion at the inlet and outlet of the septic tank (Cabin #3). The piping exiting to the septic tank that serves Cabin #1 ran into a gravel filled trench with soil and the leach field was not accepting water at an acceptable rate. The septic tank that serves Cabin #2 was full of dirt and did not contain a leach field. The septic system that serves Cabin #3 contained minor root intrusion at the inlet and outlet of the septic tank. The county approved the repair permit EM-2025-0005 on 10/20/2025.

Recommended actions: discuss the proposal and determine comments/recommendations to Mendocino County Planning and Building Services.

8.5. [B-2025-0031; Gabriel Bassan](#) (Shpak)

Applicant Request: Coastal Development Boundary Line Adjustment to reconfigure the boundary between three existing lots. Lot 1 (APNs 145-122-03, 145-121-09) will reduce to $3.07 \pm$ acres. Lot 2 (APN 145-121-08) will increase to $0.73 \pm$ acres, and Lot 3 (APN 145-121-10) will increase to $1.25 \pm$ acres.

Site address: 38050 Old Coast Highway, Gualala.

Recommended actions: discuss the proposal and determine comments/recommendations to Mendocino County Planning and Building Services.

8.6. [CDP-2020-0031; Carl Rittiman and Associates](#)

Applicant Request: Standard Coastal Development to remove an existing 157 square-foot cabin, construct a 1,911 square-foot driveway and parking area, and a 1,548 square-foot single-family residence, install a septic system, construct a supplemental well, connect to utilities including an off-site spring, and a water tank.

Site address: 46451 Gypsy Flat Road, Gualala.

Additional information: GMAC considered this project on 12/5/24 (Evans and Juengling). The purpose of this fourth referral of the proposed project is to enable consideration of additional documents:

- Water Easement Agreement
- Spring Test dated 2023
- Alternatives Analysis
- Reduced Buffer Analysis
- Fuel Modification and Vegetation Management Plan (due to how vegetated the area is, and to maintain defensible space)
- Takings Analysis (since the proposed development would be within the 50 ft buffer of identified ESHA).

Recommended actions: discuss proposal and determine comments/recommendations to Mendocino County Planning and Building Services or assign GMAC members to review the project for presentation and action at the February 5, 2026 regular meeting.
